Conditions:-

- (i) Stone Charges, Sub-division charges etc., should be collected from the requisitioning department.
- (ii) The requisitioning department should abide by all the conditions imposed by the Government.
- (iii) The land should be used only for the purpose for which it is transferred.
- (iv) The requisitioning department should return the land or part thereof to the Government in Revenue Department if it is no longer required.

2. The Additional Chief Secretary and Commissioner of Land Administration and the District Collector, Namakkal are requested to take necessary action as per the orders in para 1. above and to take necessary action to make changes in the Revenue Records immediately.
