Further, it is also informed that the “ Letter of Consent of Affiliation” issued to the Director of Medical Education, Chennai, does not confer any right for the increase of seats for the above said course at the Institution till the approval of the Government of India, New Delhi and issue of Provisional Affiliation of this University and this Letter is issued only for a specific purpose of enabling the Director of Medical Education, Chennai to apply to the Government of India, New Delhi for their approval.

CONSENT OF AFFILIATION *(for increase in MBBS seats)*

On the basis of the report of the Local Inquiry Committee **The Tamil Nadu Dr. M.G.R. Medical University, Chennai – 600 032** has agreed, in principle, to affiliate **Government Medical College, 353, Master Plan Complex, Namakkal – 637 001**, for the **increase in intake of seats in UG Medical Course** with an annual intake of 100 to 150 (**One Hundred to One Hundred and Fifty**) seats from the academic year **2026 - 2027**, subject to grant of permission by the National Medical Commission u/s 26 of the National Medical Commission Act, 2019 (30 of 2019).

This Consent of Affiliation shall be valid for three years from the date of issue. It can be used only once during this validity period, irrespective of the outcome of the application.
